#### General Terms and Conditions of rental:

## **General provisions**

These terms and conditions of lease shall form an integral component of the Rental Agreement. All rentals shall start at the Renter's designated spot and cease when the motorhome is returned to the Renter's designated spot. The Renter shall provide the Rentee a roadworthy and technically perfect vehicle together with accessories for use. The rented object is the property of Carawero AG, Werner Roos, Eistrasse 1, CH-6102 Malters LU.

# Mileage restriction

Rent 8 days or more; no mileage restriction

Rent up to 7 days; limited to 250 km per day, more kilometres CHF. 0.70 per kilometre

### Subletting

Subletting to third parties is prohibited.

### Reservation

Reservations may be made by telephone, in person or by e-mail. The Rentee shall receive with this Agreement an invoice with a payment slip. The invoice with the deposit must be paid at the latest 14 days before pick-up of the motorhome. The reservation shall be binding upon receipt of this signed Agreement.

### Driver

The driver of the motorhome must be at least 20 years old and in possession of a Cat. B driving licence for at least 12 months (observing national regulations). This Rental Agreement refers to the Rentee who is also the driver. The rental vehicle may not be driven by persons other than those mentioned in this Rental Agreement.

# Delivery and return of the rental vehicle

The motorhome shall be picked up by mutual agreement. A record shall be issued upon delivery as well as upon return. The rental vehicle must be picked up and returned at the times specified in this Rental Agreement, swept clean inside, with a full tank, and handed over without any visible defects. The Rentee hereby agrees to return the motorhome including the interior equipment and accessories in the same condition. Any missing or defective inventory shall be charged to the Rentee. If the vehicle cannot be returned at the agreed time, the Renter must be notified immediately by telephone; in addition, the Rentee must pay a surcharge of CHF 50.00 per hour (exception: *force majeure*). Damage must be reported immediately to the Renter so that spare parts can be ordered.

# **Duties of Rentee**

The Rentee must treat the vehicle with care and observe all regulations and technical rules applicable to its use.

## Servicing

The Rentee is responsible for the proper use of the motorhome. The Rentee is obliged to check the oil and water levels and tyre pressure every 2,000 km. The Rentee is liable for damages caused by improper maintenance by the Rentee or improper handling of the motorhome. Charges, diesel costs, motorway, tunnel and other road and traffic fees shall be borne by the Rentee.

#### **Prohibition**

Smoking is not allowed in the motorhome! The motorhome may not be overloaded and may not be used to transport persons or goods for a fee.

## Liability

The Renter shall not be liable for any loss or damage suffered by the Rentee as a result of a breakdown or accident or in connection with the operation of the rented motorhome. The Rentee shall be liable if the Rentee damages the rented vehicle or commits any other breach of contract.

## **Traffic violations**

The Rentee shall be liable for the consequences of traffic violations, fines for violation of traffic regulations of any kind, exceeding parking times, etc. Fines, also abroad, are collected all over Europe in all cases. In the case of parking fines, never throw away any slips of paper under the window; these are required when paying fines.

#### Repairs

Any necessary repairs must first be reported to the Renter; contact us, we will find a suitable workshop for you in your area via Google Maps. Repair costs shall only be refunded upon presentation of the receipt and return of the defective spare parts.

#### Accident

Any accident must be reported immediately to the local police station. The Renter must also be notified immediately by telephone. The Rentee shall be obliged to legibly fill out an accident report. The accident report must be completed in full with the names and addresses of any and all witnesses involved as well as the registration numbers of the vehicles involved. Clearly and succinctly describe and indicate who was in error!

### **Damage**

In the event of damage, the Rentee shall be obliged to do everything possible to keep the damage as low as possible. Damage caused to the motorhome by the Rentee shall be borne by the Rentee. The Rentee shall be liable for loss of or damage to its property as well as for the proper return of the vehicle documents.

## Vehicle insurance

Our vehicles are insured against liability with unlimited coverage (deductible of CHF 1'000.00 per claim). All vehicles shall also be fully insured. The deductible is to be borne by the Rentee in case of its own fault, as well as any damage rejected by the insurance company, such as due to gross negligence (e.g. due to alcohol). For natural events such as storms (at least 75 km/h) and hail as well as for burglary, a report must be drawn up by the groundskeeper or the police (burglary and accident) for the insurance company.

## **Cancellation cost insurance**

We recommend that you take out such insurance. If you withdraw from the signed Agreement, you will incur cancellation costs as described under "Withdrawal from this Rental Agreement".

## Withdrawal from this Rental Agreement

If the motorhome is not occupied or the intended rental period is not fully used, the rent shall still be due. The Renter must be notified of the cancellation by registered letter. For cancellations up to 90 days before the start of the rental period, a cancellation fee of CHF 80.00 must be paid; for cancellations up to 61 days before the start of the rental period, 20% of the rent shall be charged. For 60 to 31 days 50% of the rent shall be charged; and 30 to 0 days before departure 100% of the rent shall be charged.

If, for serious reasons, the Rentee is unable to embark on his or her holiday, the Rentee may arrange a substitute rentee with the Renter.

If the delivery of the motorhome is rendered impossible by an unforeseeable event, such as non-return, destruction or damage, we shall try to find a replacement vehicle but are not obliged to do so. If we do not find a vehicle, you shall be reimbursed for all payments made. No further claims may be asserted against us.

# Cleaning

If the toilet cassette is not returned in whole or in part by the Rentee, we will have to charge CHF 70.00 per hour for subsequent cleaning.

## Place of jurisdiction

CH-6102 Malters LU, Switzerland shall be the place of jurisdiction for both parties.
